

Landmark Agreements Formalised During 27th CHOGM 2024 in Samoa

Five significant agreements, were adopted during the 2024 Commonwealth Heads of Government Meeting (CHOGM), held in Samoa from 25 – 26 October 2024, underscoring Papua New Guinea’s commitment to working closely with Commonwealth partners to progressing these initiatives.

Prime Minister, Hon. James Marape, when commending the overall success of CHOGM 2024 leaders’ meeting, emphasised the importance of these agreements for Papua New Guinea and the broader Pacific region, describing them as “timely and critical” for building a resilient future.

The theme of the Meeting, ‘One Resilient Common Future: Transforming our Commonwealth’, brought together leaders from 56 Commonwealth nations, to address critical global challenges, including climate change, sustainable development, and social equity.

He reiterated his government’s commitment to working closely with Commonwealth partners to advance these initiatives.

The Key Agreements from CHOGM 2024 include:

- Ocean Declaration: The leaders adopted a groundbreaking Ocean Declaration aimed at safeguarding the health and sustainability of the world’s oceans.
- This agreement focuses on mitigating the impacts of climate change on marine ecosystems, addressing ocean pollution, and promoting sustainable ocean-based economies. Prime Minister Marape welcomed this initiative, stating, “The Ocean Declaration provides the Pacific region with a strong foundation to protect our oceans, which are vital for our food security, economic growth, and cultural heritage.”
- Climate Action and Resilience: A central pillar of the discussions was the urgent need for climate action, with leaders reaffirming their commitment to intensifying efforts to combat climate change.
- This includes scaling up adaptation and mitigation strategies, particularly for small Pacific Island nations, that face severe climate risks.
- Leaders agreed on the need for innovative climate financing solutions to support vulnerable countries.
- Prime Minister Marape stressed the importance of this agreement, saying, “Papua New Guinea and our Pacific neighbours are on the front lines of climate change.
- The commitments made here are not just about addressing environmental challenges—they are about safeguarding our future.”
- Strengthening Democratic Institutions: Commonwealth leaders pledged to strengthen democratic governance, uphold human rights, and reinforce the rule of law across member states.
- This agreement aims to promote political stability and peace through resilient democratic institutions.
- “Strong, transparent, and accountable institutions are essential for peace and development.
- This is particularly important as we work to ensure that all citizens, including the most vulnerable, are represented and protected,” Prime Minister Marape said.
- Empowering Women and Youth: Recognising the vital role of women and youth in driving progress, Commonwealth leaders agreed on new strategies to promote gender equality and youth empowerment.
- This includes initiatives to enhance entrepreneurial opportunities, increase access to education, and develop skills for the 1.5 billion young people across the Commonwealth.
- “Our youths are the future of the Commonwealth, and it is crucial that we invest in their potential. Likewise, empowering women to participate fully in economic and social life is essential for our nation’s prosperity,” said Prime Minister Marape.
- Economic Recovery and Sustainability: In the face of ongoing global economic challenges, Commonwealth leaders agreed to support sustainable economic recovery and growth. This includes promoting trade, investment, and innovation, as well as fostering resilient economies that can withstand future disruptions.

Prime Minister Marape highlighted the importance of this agreement for Papua New Guinea's economic development, saying, "A sustainable and inclusive economic recovery is key to building resilience."

We must ensure that all citizens benefit from growth, particularly as we recover from the economic impacts of the pandemic."

In addition to these landmark agreements, CHOGM 2024 also included discussions on key Commonwealth programmes such as health, education, and digital transformation.

The meeting featured ministerial and bilateral sessions, as well as four major forums—focused on youth, women, business, and people—where participants shared best practices and showcased progress on key issues.

Prime Minister Marape expressed his gratitude to the Government of Samoa for hosting a successful CHOGM and praised the leadership of His Majesty King Charles III, who attended his first CHOGM as Head of the Commonwealth.

He also acknowledged the work of outgoing Commonwealth Secretary-General Patricia Scotland, saying, "Her leadership has been instrumental in advancing the interests of small states like Papua New Guinea, and we are grateful for her dedication to the Commonwealth."

Prime Minister Marape reaffirmed Papua New Guinea's commitment to the Commonwealth's shared values and goals.

"Through collective action, we can address the challenges of today and build a resilient, prosperous future for all members of our Commonwealth family."

Papua New Guinea, Vanuatu Sign Framework Agreement to Enhance Economic Cooperation

A framework agreement was signed in Samoa on Friday 25 October, between the Prime Minister of Vanuatu, Hon. Charlot Salwai Tabimasmas and Prime Minister of Papua New Guinea, Hon. James Marape, committing the two countries to pursue, develop, and implement economic and technical cooperation activities for the benefit of their peoples.

The signing took place at Taumeasina Island Resort in Apia, Samoa, and on the margins of the 27th Commonwealth Heads of Government Meeting (CHOGM).

Prime Minister Marape described the agreement as a milestone achievement for both countries, whilst fostering and deepening a long relationship they have, as members of the Melanesian Spearhead Group and also with Papua New Guinea playing a small role in the birth of Vanuatu as a country.

Prime Minister Tabimasmas in response, expressed appreciation to PNG for its assistance in the past, including sending relief aid to Vanuatu after it was hit by a cyclone.

He highlighted that this was a result of discussions he held with leaders from PNG, and thanked government officials from both countries for their efforts in ensuring those discussions resulted in the development of this framework agreement.

The agreement provides an overarching framework under which the two parties are able to initiate, develop, and implement subsidiary cooperation understanding and agreements between various sectors and areas of development.

The scope of cooperation in the agreement includes, but is not limited to: Agriculture; Air Services; Bilateral Trade and Investment; Climate Change and Environment; Defence and Security Cooperation; Double Taxation; Education and Human Resource Development;

Disaster; Health and Medical Services; Infrastructure; Investment Promotion and Protection; Marine and Fisheries Cooperation; Policing; Mining and Energy; Tourism and Culture

The event was witnessed by PNG's Minister for Foreign Affairs Hon.

Justin Tkatchenko, Minister for International Trade and Investment Hon. Richard Maru, Minister for Fisheries and Marine Resources Hon. Jelta Wong and Minister for Community Development, Religion and Youth Hon. Jason Peter.

Government Advocates for cleaner energy, calls for action to reduce coal production

Prime Minister Hon. James Marape has emphasised the urgent need for Papua New Guinea to be among global leaders

to shift to cleaner energy without delay, with his government now seeking out investors to participate in cleaner energy solutions.

In his address at the recent 2024 Petroleum and Energy Conference at the Hilton Port Moresby, Prime Minister reaffirmed his government's

focus on cleaner energy, while at the same time, offering incentives and protections to investors to secure their investment in country.

"I want to assure you that whatever regime shifts we embark upon, one thing is certain, and that is, our provisions to protect our investors making a healthy return on their investments will always be protected."

The Prime Minister is adamant in opening up more liquified natural gas (LNG) as transitional energy and eventually move to cleaner energy sources, while moving away from coal production and other heavy fossil fuels.

"I firmly believe that liquified natural gas (LNG) is the best energy source for transition between now and life after 2050, if we are to keep Mother Earth.

"LNG is cleaner, more efficient, and aligns with our goal of reducing carbon emissions. It is the lowest hanging fruit in terms of transitional energy with availability of technologies and present use including diversification of LNG to fuel," Mr Marape added.

Whist LNG remains the better option cleaner transitional energy choice, Prime Minister also offered PNG's vast potential in generating

clean energy from hydro, thermal, and solar sources, to those who want to venture into future renewable energies in line with environmental stewardship as "our present moral responsibility toward our earth's future."

"PNG is getting our house in order to "think globally and act locally".

"PNG is a carbon-negative country."

"Our forest have over 100 million metric tons of carbon absorption capacity, our own carbon foot print remains under 10 million metric tonnes, and despite the high cost of energy, we choose to differ now and into the future.

"We want to remain a clean green country and we want to make and lead this transition to clean energy," said Prime Minister.

He added, "As we work toward a cleaner energy future, research into cost-effective alternatives remain crucial, however, we cannot delay transitioning to LNG and other renewable sources.

"We must act now to reduce our reliance on coal and heavy oil/fuels."

The Petroleum and Energy Conference was held at the Hilton Hotel, Port Moresby, from 17 – 18 October, and attended by both local and international participants. ■

Western Province Launch USD1.2 Billion Agro Forestry Project

The USD 1.2 billion (K4. 8 billion) Agro Forestry Project in the Western Province is finally being realised, with the official signing of the project at Government House on Tuesday 29 October 2024.

Prime Minister Hon. James Marape, in commending the Provincial Member for Western, Province, Hon. Taboi Awi Yoto, and the people of the province for their commitment in moving the Foreign Direct Investment to completion, said it was a great moment of collaboration and partnership between the local landowners, the Provincial Government, and the National Government.

"I highly commend Western Governor Hon. Taboi Awi Yoto, the Western Provincial Government, all leaders past and present, and the people of Western Province for staying united in

came to fruition.

"With the help of the Marape-Rosso Government to push it over the crossing line, we have arrived at this moment of its signing. This Project has been a long time coming and today is truly a historical moment," said Prime Minister Marape.

Governor Yoto also expressed his gratitude for finally reaching the signing of the project, adding, "Some people who initiated and had the dream back then, have gone before us and are not here today. It is really a historic and joyous achievement."

Mr Yoto further thanked the government for supporting his people of Western Province in ensuring that this Project carries through.

"I also thank the government ministers who have assisted in making this dream come true, since the Project idea was initiated in 1997.

"I thank the Developer who has

chosen our country and province to invest in. We will work together and make sure this Project is implemented successfully as agreed today," Mr Yoto added.

In addition, Prime Minister Marape highlighted the transformative impact of the project, stating, "Today I have the absolute pleasure of seeing a USD1.2 billion (K4.8 billion) Agro Forestry Project for remote parts of the midlands of Western Province.

"Given that the Western Province, having 98,000 square kilometres of land, has often been left behind in the past as far as major development projects are concerned, this Project will see over 300 kilometres of a sealed, all-weather Road that will run from Kiunga to Nomad to the Borders of Gulf Province, and later, we will push this Highway to Kikori (Gulf Province)."

"The logs harvested from this Road Corridor will be processed in-country

by 2028 in a base at the deep water area of Strickland River; it will have electricity sourced and agriculture and reforestation done on the harvested area."

With this 30-year project now officially underway, it is expected to positively impact the North Fly, Middle Fly, and Delta Fly districts, while linking South Fly to Gulf Province via a trunk road.

As with all national impact projects under Prime Minister Marape's Government, the Agro Forestry Project is structured to provide Papua New Guineans with a potential 51 percent interest upon full maturation. Prime Minister Marape explained the equity distribution, noting that "Papua New Guinea will begin with a 20 percent free carry equity stake in this Project, with 10 percent for the landowners of Western Province, 5 percent to the Western Provincial Government, and 5 percent to the National Government.

"We have negotiated for room to increase PNG's stake incrementally as the Project matures, allowing the State to bid to increase its stake at cost by the fifteenth year.

"By the twenty-fifth year, the State will be able to freely take the remaining 31 percent, resulting in a partnership of 51 percent for PNG and 49 percent for the investors."

Prime Minister Marape assured that Western Province stands to gain 70 percent of the project benefits, particularly through the infrastructure provided at no cost to the State.

The resource owners will receive royalties, premiums, and payments in addition to job opportunities, training, and business spin-offs.

According to the Prime Minister, the developers have not sought tax exemptions or holidays, adding the State will also benefit financially from this Project.

The project, based in Yabo in the Middle Fly District, includes a permanent River Port on the East Bank of Yabo and a 300 km asphalt-sealed trunk road connecting Kiunga, Nomad, Wawoi Falls, Balimo, and extending into South Fly and Gulf Province.

An additional 300 km of feeder roads will link communities within the project boundaries.

Prime Minister Marape further encouraged all Provincial Governors to attract investment in agriculture, sustainable forestry, fisheries, tourism, and other non-resource sectors, and urged them to coordinate with their landowners to seek out investors, and bring Foreign Direct Investment to respective provinces.

"The National Government is prepared to support, as we have done for Western Province," he said.

Epoca Group Ltd, the Italian-based project developers, attended the contract signing and expressed their commitment to delivering on this historic venture.

Company Director Gilberto Maggiolo shared their optimism about the project's potential to benefit Western Province and Papua New Guinea while securing a return on their investment.

Prime Minister Marape noted, "PNG beneficiaries will initially have a 20 percent share in the Project. After 25 years, the equity of PNG beneficiaries will increase to 51 percent.

This Project is expected to employ over 3,000 people and has many spin-off benefits, and will be compliant with the country's environmental laws and has a five-year Project review clause to ensure compliance.

In line with the Government's strategic direction, Prime Minister Marape added, "Our Government has in the pipeline oil palm, rice, cattle, and coffee, as well as the expansion of cocoa and copra.

"We also have coastal areas for fisheries expansion. I ask Provincial Governors in peaceful regions to seek investors, and my government will provide the necessary support, as we are doing for Western Province."

Since taking office, the Marape-led Government has emphasised a shift toward sustainable sectors, with a vision for national growth that involves broader economic participation for the people of Papua New Guinea. ■

Choices in energy production can result in climate crisis, says Marape

Prime Minister Hon. James Marape, has emphasised that choices made in energy production and consumption, and their far-reaching consequences on future generations, can directly be connected to climate crisis.

In his address to the Petroleum and Energy conference at the Hilton this month, the Prime Minister further called for urgent response to climate crisis being faced today, as global warming and climate change and its effects are now common knowledge in the Pacific, and have become a real threat, due to rising sea levels and changing weather patterns.

"Even though Papua New Guinea and its sister, small island countries of the Pacific have very low carbon footprint, we face the highest risk from the climate crisis."

"I want to bring the spotlight Reflecting on the production of heavy carbon-filled fossil fuels, especially coal, Prime Minister Marape, stressed that it was hard to believe that in this modern age of space travel and superspeed technology, the world is still burning coal.

"Yet, this is true. Coal accounts for the largest share of electricity production worldwide, with gas coming in only at second place.

"In the Asia region where economic growth and high populations have placed very high demands on energy consumption, the reliance on coal is the highest worldwide."

The International Energy Agency has continually been publishing reports on the alarming trends of coal consumption by countries; and as indicated, the 2020 – 2023 figures reveal that China accounts for a massive 50.5 percent of the global coal consumption, followed by India at 11.3 percent. United States comes in next at 8.5 percent; Germany at 3 percent; and South Africa at 2.4 percent, Poland, Australia, and Brazil are also listed.

"The call to prioritize the wellbeing of our planet is more urgent now than ever before.

This call has become even more urgent with more nations switching back to coal in Europe and Asia and elsewhere.

"As we work toward a cleaner energy future, research into cost-effective

alternatives remain crucial, however we cannot delay transitioning to LNG and other renewable sources. We must act now to reduce our reliance on coal and heavy oil/fuels."

Prime Minister Marape emphasised the need for collaboration in achieving this vision, and urged governments, companies, and individuals to join forces and prioritize environmental stewardship.

"Together, we can create a sustainable energy landscape that benefits our nation, the region, the world, and our planet."

Mr Marape further invited investors and experts to explore and develop these resources, leveraging our strategic location closer to Asia markets.

"Our vast forests also provide a unique advantage, offsetting carbon footprints and making PNG an attractive destination for environmentally-conscious investments."

The conference aimed to seek ways to develop, regulate and promote the energy sector, and focus on its impact on planet earth. ■

Papua New Guinea Withdraws from COP29

Foreign Affairs Minister, Hon. Justin Tkatchenko, has announced Papua New Guinea's non participation in the upcoming 29th United Nations Framework Convention on Climate Change Conference of Parties (UNFCCC COP29) this year at the political level, in defense of forest nations and small island states. Minister Tkatchenko raised Papua New Guinea's concerns at the Commonwealth Ministerial Meeting on Small State (CMMSS), in Apia, Samoa, ahead of the CHOGM Leaders' Week. The CMMSS is a meeting of Commonwealth Foreign Ministers which is convened prior to the Commonwealth Heads of Government Meeting (CHOGM), and provides a platform for Ministers of Foreign Affairs to discuss challenges confronting commonwealth small states, including concrete action to strengthen resilience of these countries building on existing global development frameworks for sustainable development. The Commonwealth comprises 56 countries of which 33 are small states both island and landlocked including nine Pacific Island countries out of the total 42 Small States in the United Nations. The 2024 CMMSS focused on members' efforts to advance the implementation of the Advocacy Strategy for Small States on: (i) mobilizing concrete actions to build resilience to address economic vulnerability; (ii) enhance climate action; and (iii) support small states to build fiscal resilience and improve debt sustainability while amplifying advocacy on access to concessional

development finance towards building resilient economies for small states in the Commonwealth. In this context, Minister Tkatchenko, emphasized that this decision reflects the broader frustration felt by nations like Papua New Guinea (PNG), which suffered from the impacts of climate change, with no meaningful support from the global community. "Papua New Guinea is making this stand for the benefit of all small island nations. We will no longer tolerate empty promises and inaction, while our people suffer the devastating consequences of climate change." Minister Tkatchenko highlighted the various ways climate change is ravaging PNG, from rising sea levels and natural disasters to landslides, floods, and droughts. "Yet, despite contributing little to the global climate crisis, countries like PNG are left grappling with its severe impacts." He said Papua New Guinea is taking this stand for the benefit of all the small island nations, recognising that not much traction has been made to help small states, particularly Pacific Island small states. "Small island states have had difficulty accessing climate finance over the recent years, despite making high level representation at the UNFCCC COP, yet nothing concrete has come out of such major multilateral meeting." While it was noted that the outcome of the CMMSS would prepare commonwealth countries to make collective representation at the forthcoming COP29 in Azerbaijan, to progress the commonwealth efforts on building resilient economies and associated environmental commitments, Minister Tkatchenko informed that Papua New Guinea will

no longer listen to empty promises. Minister Tkatchenko has expressed concern over the international community's failure of its financial and moral commitments, leaving smaller nations like PNG to do things on their own in the face of increasingly frequent and severe climate events. "The pledges made by major polluters amount to nothing more than empty talk. They impose impossible barriers for us to access the crucial funds we need to protect our people. Despite continuous attempts, we have not received any support to date." Minister Tkatchenko stressed that Papua New Guinea is one of the third (3rd) biggest rain forest nations of the world, serving as the major lungs of the world that cleans the carbon dioxide that major greenhouse gas emitters (countries) produce, thus is an integral global lifeline in saving the

world and the planet from disaster. In explaining PNG's withdrawal from COP29, the Minister added, "We need action, not more talk. "The last three COP meetings have gone around in circles, producing no tangible results for small island states. "COP29 will be no different, so PNG will not participate at the political level recognising the lack of respect for forest nations in the big carbon sink until some progress becomes evident to address the plight of PNG and other small states." Minister Tkatchenko called attention to the hypocrisy surrounding global climate financing and the disregard for forest nations, which act as critical carbon sinks for the planet. "The international community has shown a total lack of respect for countries like ours that play a crucial

role in mitigating climate change. We are tired of being sidelined." The Minister affirmed that Papua New Guinea would explore independent solutions to protect its people and natural assets, free from the empty promises of the global powers, as a way forward. "If we must cut down our forests to sustain ourselves and develop our economy, so be it. Papua New Guinea will no longer wait for empty words while our people suffer. We are taking control of our destiny." This bold decision underscores Papua New Guinea's frustration with the international community's inaction and sends a clear message: forest nations and small island states deserve more than lip service-they deserve real, tangible and immediate action. ■

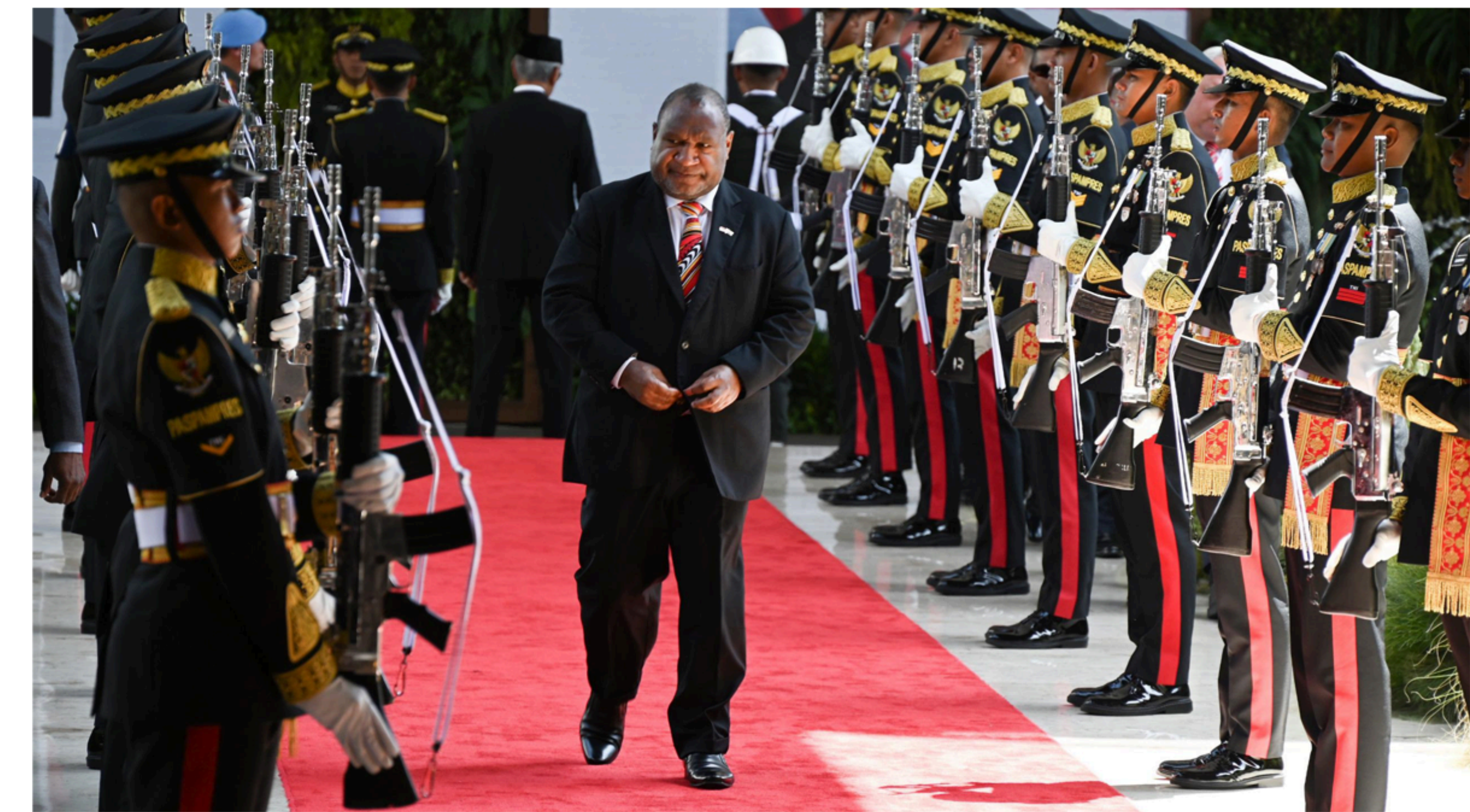
Papua New Guinea is committed to building a stronger alliance with Indonesia from shared border, interconnected histories and economic interests Prime Minister Hon. James Marape in his remarks ahead of the inauguration of H.E. Prabowo Subianto as Indonesia's eighth President on Sunday, October 20, 2024, reaffirmed Papua New Guinea's commitment to building a

stronger alliance with Indonesia. "Indonesia is a vital partner in the Pacific," Prime Minister Marape stated. "Our shared border, our interconnected histories, and our mutual economic interests make us natural allies. "I look forward to strengthening our countries' bond and fostering further cooperation on regional prosperity and stability." Prime Minister Marape's attendance

at this significant ceremony in Jakarta underscores the growing diplomatic and economic ties between the two neighboring nations. His presence highlights the recent expansion of PNG-Indonesia relations beyond traditional border security to include economic development, educational exchange, and trade cooperation. Prime Minister Marape's visit builds upon discussions held in August with President-elect Subianto in Port Moresby, where the leaders outlined aspirations for enhanced collaboration. "The bond between Indonesia and Papua New Guinea is one of kinship," President-elect Subianto remarked at that time. "We are joined together and should be like real brothers. Cooperation in defense, education, and trade will strengthen our shared vision for a prosperous future" In recent years, Indonesia's significant economic growth has set an example for the Pacific region, positioning the country as a global economic player. "Indonesia's economic journey offers valuable lessons for Papua New Guinea," Prime Minister Marape observed.

"We look forward to learning from Indonesia's successes in sectors like mineral processing and trade, and we welcome opportunities for our nations to grow together. "This inauguration marks an opportunity for PNG to further its role in the regional economic landscape by aligning closely with Southeast Asia's largest economy." This visit follows PNG's ratification of a defense cooperation agreement with Indonesia earlier this year, establishing a framework for joint

border management and enhanced security efforts. In addition, a Memorandum of Understanding on parliamentary cooperation reflects a commitment to strengthening political and economic ties. Prime Minister Marape invited President-elect Subianto to join PNG in celebrating its 50th Independence anniversary next year, underscoring the bond between the two nations — a gesture that the President-elect warmly accepted. ■

Marape Among World Leaders who Witnessed Inauguration of President Subianto in JAKARTA

Prime Minister Hon. James Marape was among world and regional leaders who witnessed the inauguration of Indonesia's incoming leader, President Prabowo Subianto on Sunday 20 October, 2024 in Jakarta.

On his arrival from Indonesia, Prime Minister highlighted the expanding PNG

-Indonesian relationship undertaken under the Marape-Widodo administrations that is now affirmed to continue under President Subianto, in a press conference.

He emphasized the exponential growth of Indonesia's economy which currently sits at nearly \$1.5 trillion

with Indonesia aggressively pushing this toward a first world nation status by 2045, and Papua New Guinea's opportunity to capitalize on its proximity to Indonesia.

He described the inauguration ceremony as colourful and an eventful transition of leadership, where they

witnessed the 7th president passing on leadership to the 8th president.

In his address, the President-elect highlighted priority areas for his country, among which included, the need for food and energy security for Indonesia, poverty alleviation for low-income earners and the rural population, and moving Indonesia toward a developed nation in the next 20 years, embracing peaceful living and co-existence with neighbours, and entrenching democracy in Indonesia.

Following the inauguration ceremony, PNG was among a few nations that was allocated time for a bilateral meeting with President Subianto, where he highlighted pertinent issues relating to Papua New Guinea and Indonesia.

"We affirmed that the work that President Widodo and I started must continue.

These are in areas of education, land transport, economic cooperation, trade & investment, oil palm, electricity supply and all other related issue".

Prime Minister Marape has since held three bilateral meetings with President Widodo.

Meantime, President Subianto has affirmed this work will be elevated for both nations linked by a land border.

Prime Minister Marape also revealed the new president has sought his advice in relation to the Melanesian people of West Papua, Indonesia's eastern province, where the Prime Minister committed to greater autonomy and offered amnesty to law offenders.

"This is the first time for me to see openness on West Papua and whilst it is an Indonesia sovereignty matter, my advice was to give respect to land and their cultural heritage.

"I commend the offer on amnesty, and PNG will continue to respect Indonesia's sovereignty."

Mr Marape reaffirmed his government's intention to work just as closely with President Subianto in expanding further the areas of trade and investment, especially in business-to-business and people-to-people relations.

"In all areas of discussion, we look forward to working with Indonesia, not just on the border issues, but on people-to-people as a nation that shares land on this side of the world."

With Indonesia's direct neighbours, Prime Minister Marape joined the Prime Minister of Malaysia, Prime Minister for Singapore, President of the Philippines, Sultan of Brunei, Prime Minister of Timor Leste, and the Deputy Prime Minister of Australia.

Others within the vicinity who attended included the Prime Minister of Solomon Islands, the Prime Minister of Vanuatu, the Prime Minister of South Korea, the Vice President of China, the Deputy Prime Minister of New Zealand, the Deputy Prime Minister of Russia, the Vice President of Thailand, and the Vice President of Vietnam.

United States of America, India, United Arab Emirates and Saudi Arabia were represented by special envoys.

Papua New Guinea, Rwanda may soon foster deeper collaboration in trade relations and climate change

Prime Minister Hon. James Marape had a bilateral meeting with President of Rwanda His Excellency Paul Kagame on the sidelines of the Commonwealth Heads of Government Meeting (CHOGM) in Samoa, on Thursday 24 October 2024, expressing optimism that this meeting would result in both countries fostering deeper collaboration in trade and people-to-people relations, as well as Rwanda extending its assistance in other areas such as climate change.

Prime Minister Marape paid tribute to President Kagame for contributing to the Commonwealth countries as Chair-in-Office of the Commonwealth Secretariat in the last two years.

Rwanda hosted the CHOGM in 2022, and PNG was not able to attend due to its National General Elections, for which Prime Minister Marape expressed his regrets.

Prime Minister Marape noted that Papua New Guinea and Rwanda have engaged on several occasions at the multilateral level but no concrete agreements have been progressed yet bilaterally.

In addition, Prime Minister Marape described Rwanda as one of Africa's fastest-growing economies, and a model of post-conflict economic reconstruction and social cohesion.

"Its success in governance, Information and Communications Technology (ICT), and infrastructure development presents an opportunity for PNG to explore knowledge-sharing initiatives," said Prime Minister Marape.

He noted Rwanda's ranking among the top in Africa in the World Bank's Ease of Doing Business index, showcasing its commitment to creating a favourable environment for investors and entrepreneurs.

"Papua New Guinea with its abundant natural resources and growing focus on

diversifying its economy, stands to benefit from strategic engagement with Rwanda, particularly in areas such as ICT, tourism, governance, and sustainable development."

Other areas that PNG can benefit from Rwanda include:

- Rwanda's success in governance reforms, particularly in anti-corruption measures and the creation of transparent institutions. This is imperative to achieving national development goals. Rwanda's approach

to public service delivery and business-friendly policies provides a model for improving PNG's investment climate.

- Both PNG and Rwanda are active members of international organizations such as the United Nations and the Commonwealth. They share mutual interests in sustainable development, climate action, and South-South cooperation, providing avenues for enhanced diplomatic engagement.

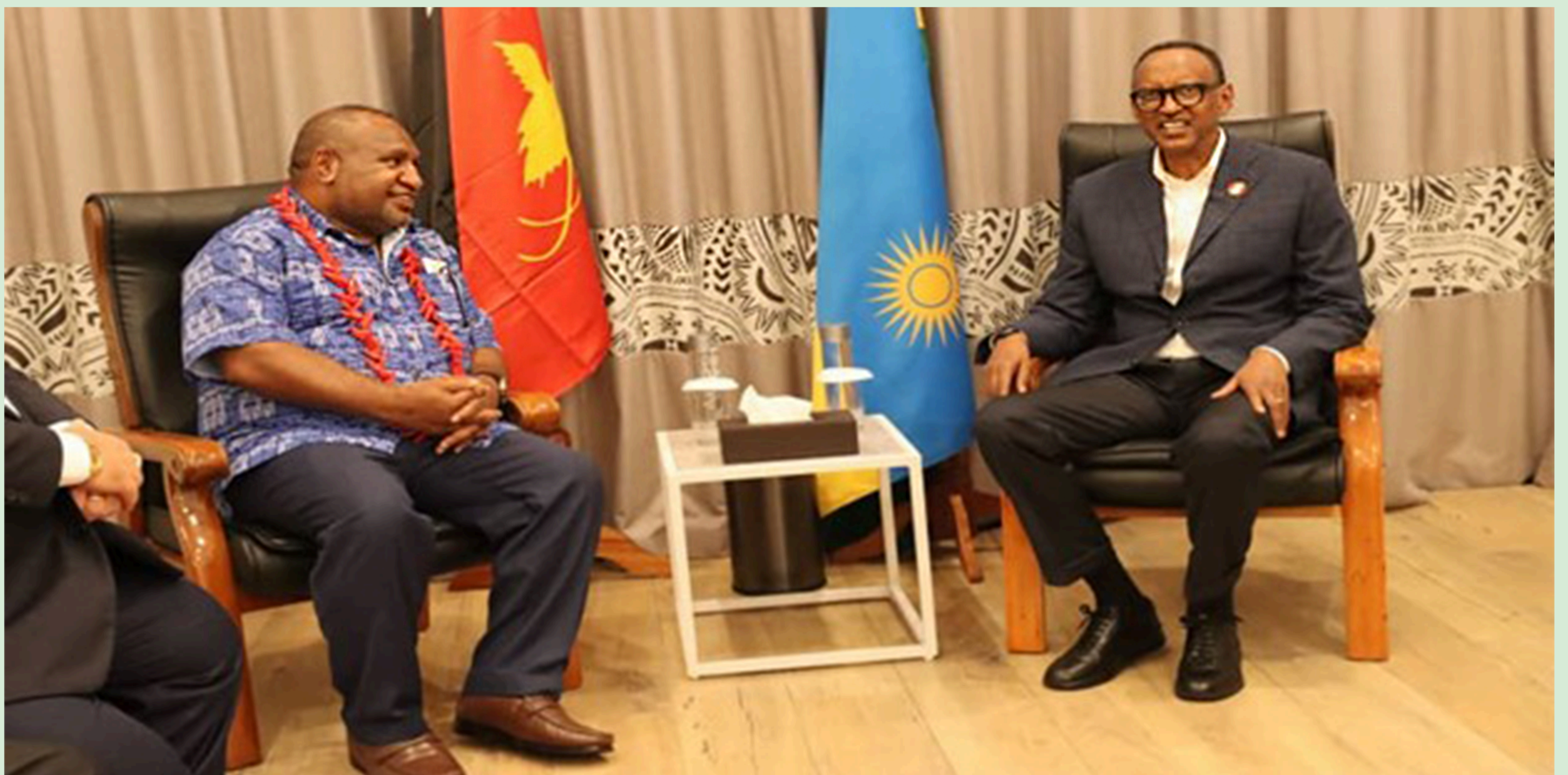
Prime Minister Marape also indicated sending a delegation to Rwanda before the 50th Independence Anniversary of PNG next year, to seek opportunities of investment and trade with PNG and to invite potential Rwanda investors who are looking to do business with PNG.

Moreover, Mr Marape extended an invitation to President Kagame to attend PNG's 50th Independence Anniversary next year, for which Pre-

sident Kagame said he would be honoured to attend the 50th anniversary celebrations in Port Moresby.

On the other hand, President Kagame acknowledged the long distance that they travel to this part of the world, but said the two countries could still make their relationship stronger and beneficial.

Both leaders met on Thursday 24 October, ahead of the official opening of the CHOGM on Friday, 25 October.

Prime Minister Hon. James Marape commended Samoa on successfully hosting the 27th Commonwealth Heads of Government Meeting (CHOGM), as he reaffirmed the Commonwealth's place among the world's families of nations.

The Prime Minister made these remarks as he departed Apia on Sunday, 27 October 2024 for Port Moresby.

"I offer my highest commendations to Prime Minister, Hon. Fiame Naomi Mataaafa, her government and the people of Samoa on successfully hosting this Commonwealth meeting."

Prime Minister Marape further reaffirmed the importance and value of the Commonwealth association, which he said continues to safeguard and promote ideals important to its member countries around the world, besides the economic significance of combining 56 nations as a block.

"The Commonwealth has found its place again in the world's family of nations.

We have many blocks of nations in the world, whether political or economic; some based on ideology, some based on commerce and trade, others based on region.

"But this family of nations, which covers a good part of the world, shares ideals of democracy, free trade, and promotes equality and equity.

"Most of us come from a shared colonial past, but from Papua New Guinea's perspective, we say 'past is in the past'. We look forward to constructing a future for individuals, families and our people."

"The Commonwealth family of nations has over 2.6 billion people. The combined economic volume of these nations equals to \$20 trillion making it a massive economic block in terms of people and economy, globally speaking," said PM Marape.

The Prime Minister believes the 27th CHOGM provided an opportunity for many countries with similar colonial background to look back on their past, while the members made commitments to move into the future.

"My own experience in this recently-concluded CHOGM was that it was seen from a context of our colonial past, but recultivated from the perspective of working toward the future by embracing contemporary issues of the world like climate change, economic and trade barriers, regional and inter-regional conflicts taking place globally.

"This block of nations emerged stronger after the Apia meeting to talk about our fight for equity and equality of people, fair trade, and leaving no one behind, which is the United Nations charter.

"Right behind the United Nations, the Commonwealth exist as the second biggest block of nations – of

diversity blending into one."

The Prime Minister highlighted Papua New Guinea's stance, delivered to the 27th CHOGM.

"Papua New Guinea spoke on the theme of reflecting the diversity of humanity. We have over 800 languages and many tribes within these language groups.

Despite our vast diversity, we are able to hold together 49 years on since gaining Independence and together facing our 50 years of nationhood next year, 2025.

"The Commonwealth, in every sense, represents a similar diversity on the global scale. Fifty-six (56) nations from all continents and areas of Planet Earth coming together in the goal of sharing beliefs and value of democracy, free trade, and equality of people, irrespective of religious preferences, individual cultures and differences, race and colour, by embracing our diversity and living together as the human race on Planet Earth," said Prime Minister Marape.

The Prime Minister arrived in Samoa on Thursday, 24 October 2024, joined the leaders for the opening of the CHOGM and meetings on Friday, 25 October 2024, and departed Samoa on Sunday 27 October 2024.

Minister for Foreign Affairs, Hon. Justin Tkatchenko attended Saturday's session on behalf of the Prime Minister, while he observed Sabbath.

He emphasized China’s leadership in telecommunications, including advancements in 5G and ongoing research into 6G.

Ambassador Yang reaffirmed China’s commitment to supporting Papua New Guinea’s development, outlining principles of cooperation: “No politics, no intervention in politics, and no empty promises.”

Minister Masiu further emphasized the transformative impact of digitalization on NBC.

“Digitalization of NBC is where our future lies,” he declared.

Minister Masiu outlined the phases of the digitalization project, highlighting that phase one already covers 10 provinces, with phase two set to extend to 12 provinces,” he said.

“This OB Van is a fully pledged studio on wheels.

We’ve tested it in the live Broadcast of the Pope’s visit.

“It is important that we partner with China to bring in important tools for us to improve Broadcast, and consistent with the one NBC brand, it has radio broadcasting capabilities in there.

“It will drastically enhance NBC capabilities to Broadcast national events for our nationwide audience so that they can just stay home and witness events instead of coming out and risking their safety.”

He added the van is one of its kind in the country and in the South Pacific, and urged the NBC staff to look after it.

The hybrid meeting, co-chaired by ADB Country Director for PNG Said Zaidansyah and the Department of National Planning and Monitoring Acting First Assistant Secretary Reichert Thanda, and attended by government officials, project directors, and ADB staff, discussed the overall performance of the portfolio, reviewed projects, and delegated responsibilities with executing agencies and implementing agencies.

“As the biggest multilateral development partner of PNG, ADB will continue to support diversified, sustained, and inclusive growth in the country,” said Mr. Zaidansyah.

“The development impact and effectiveness of ADB’s support depend on the quality of the portfolio performance and we will continue to collaborate with the government to improve this and build the capacity of the relevant government agencies.”

ADB’s active program in PNG includes 15 loans and 6 grants with 10 projects amounting to \$1.38 billion.

The largest sectors ADB is supporting are transport (roads and civil aviation)—comprising 60% of the total active portfolio—and energy (20%) in response to the large infrastructure gap in the country.

The human and social development sector, building resilience to climate and supporting gender equity, are also integral parts of ADB’s active portfolio. ADB is also actively working on public sector management including state-owned enterprise reform.

The action plan designed to improve the portfolio performance focuses on contract and project management, procurement, financial management, social and environmental safeguards, and gender equality. ADB and the government will closely monitor the progress of the agreed actions.

ADB is committed to achieving a prosperous, inclusive, resilient, and sustainable Asia and the Pacific, while sustaining its efforts to eradicate extreme poverty. Established in 1966, it is owned by 69 members—49 from the region.■

"I encourage our PNG-owned businesses operating here and those looking for investment opportunities in the areas of finance and banking, tourism, and the construction industry to diversify their investments in Apia.

"I see the success of many PNG-owned businesses like Bank South Pacific (BSP), which has a strong presence in Samoa and the Constantinou Group of Companies, which has invested in the construction and hotel industry," he said.

Prime Minister has also encouraged investors to seize the opportunity to do business in Samoa and the other Pacific Island countries.

Mr Marape made these remarks at a business breakfast meeting organized by the Samoan business community at the Taumeasina Island Resort, in Apia on Friday 25 October.

Prime Minister Marape informed the Samoan-PNG business community of his government's intention to make the economic climate conducive for businesses to invest and operate in PNG, as well as expanding to other Pacific Island countries.

He added the government was considering removing the impediments and improving the ease of doing business in the country to assist with their operations.

"We have a good business arbitration system in place where issues over business contracts and dealings are mediated for a win - win outcome

between the government, developers and or landowners so that both sides interests are protected and cared for when conflicts arise.

"PNG looks forward to further expansion and continued presence of PNG businesses operating here in Apia, Samoa, and our people-to-people relations especially in tourism," said Prime Minister Marape.

The Samoa business community spoke highly of major PNG companies like Bank South Pacific (BSP) and the Constantinou Group of Companies operating in Samoa.

The Constantinou Group owns and operates the Taumeasina Island Resort, and its Hebou Construction is eyeing interest in the Samoan construction sector.

The PNG Government has shares in Bank South Pacific and the Taumeasina Hotel through landowner interests.

Prime Minister Marape attended the 27th Commonwealth Heads of Government Meeting in Apia, Samoa, followed by the Executive Session on Friday 25 October 2024.

The meeting was attended by the Executive Director of Australia-PNG Business Council Frank Yourn, Group Chief Executive Officer of BSP Financial Group Mark Robinson, William Blank of Hall Contracting who has done dredging work on some of PNG's ports like Lae and Port Moresby and PNG's Honorary Consul to Samoa, Fiona Ey.

Business representatives and the community thanked the PNG Government support to PNG businesses like BSP and Constantinou group for investing in Samoa and called for further investment in the construction sector.

Prime Minister Marape also thanked BSP as a PNG bank in its support to the Samoan Government as a major sponsor of the CHOGM. ■

Land Commission Progresses Research into Colonial Land Acquisitions in Germany

The Government, through the Papua New Guinea Land Commission is currently searching into colonial land acquisitions at the Bundesarchiv, the Federal Archives in Berlin, Germany.

Minister for Justice and Attorney General, Hon. Pila Niningi, when commending the Land Commission for its ongoing efforts, remarked, the research was a crucial step in addressing the historical injustices related to land ownership and will guide future policies to protect the rights of citizens.

The Land Commission team, led by Chief Commissioner Mr. Molean Kilepak, has made remarkable progress, analyzing over 25,000 slides so far, from various microfilm files related to German New Guinea.

"This initiative is an important step toward reconciling our colonial past.

By thoroughly examining the historical records, we can better advocate for the rights of our citizens and inform our policies to support rightful land ownership."

The Land Commission team had meetings in Berlin, including scheduled discussion with Hon. Katya Keul, Minister of State Assisting the Federal Foreign Office of Germany.

These meetings will provide a platform to strengthen bilateral relations and explore potential support for the Land Commission's work.

Furthermore, Minister Niningi highlighted the potential for expanding research opportunities at additional archives, such as the Geheimes Staatsarchiv, the Political Archive of the Foreign Ministry and the Church Archives which will enrich the country's understanding

of this complex history.

"Our goal is to compile comprehensive data that can inform our legislative reforms and empower our communities," he added.

The Minister expressed his gratitude to the Marape-Rosso Government, the German Federal Foreign Office and other diplomatic partners who have supported the Land Commission on its mission to retrieve Papua New Guinea's colonial land acquisition records from Germany.

He further thanked the Land Commission team for their dedication and professionalism in this critical undertaking.

He reassured the public that updates will be provided as the research progresses, reinforcing the government's commitment to addressing historical land issues. ■

Marape Refers to Office of the Registrar of Political Parties and Candidates as “Watchdog of Democracy”

Prime Minister Hon. James Marape has praised the Office of the Registrar of Political Parties and Candidates, referring to it as a “watchdog of democracy” for Papua New Guinea.

As the organisation responsible for enforcing the Organic Law on Integrity of Political Parties and Candidates (OLIPPAC), Prime Minister Marape emphasised the importance of the Registrar's role in safeguarding the nation's democratic principles.

Addressing the launch of the Office's new Corporate Plan on Wednesday, 30 October, Prime Minister Marape urged the Registrar and staff to uphold the highest standards in their work to ensure the resilience and integrity of Papua New Guinea's democracy.

Reflecting on the nation's political journey since 1975, Prime Minister Marape highlighted the challenges of political instability that have affected Papua New Guinea, especially in times of economic and political hardship.

He credited the late Prime Minister Sir Mekere Morauta, who introduced OLIPPAC in 2001, for establishing a foundational framework to promote stability.

"Sometimes I look back and wish that a Prime Minister like Sir Mekere Morauta, Sir Julius Chan, or Sir Michael Somare had 10 consecutive years or more of leadership of this country so that we would have been much better placed than we are as a country today, as far as social and economic development is concerned," Prime Minister Marape said, reflecting on the lack of continuity in leadership that has historically hindered sustained development.

Expressing his support for the Office of the Registrar, Mr Marape reaffirmed his government's commitment to empowering the “watchmen and watchwomen” responsible for overseeing political party integrity.

He noted that their role is essential not only during National General Elections but throughout a government's term to ensure that the political system remains rooted in democratic values.

The Prime Minister highlighted OLIPPAC as one of the most significant reforms in Papua New Guinea's political history, attributing its success to the efforts of late Sir Mekere Morauta in promoting reforms that strengthened the

nation's governance.

"Some reforms must be made in the context of us going forward, especially under the shadow of 50 years of our nationhood," he said, signaling a readiness for further improvements in PNG's political landscape.

Prime Minister Marape also referenced the legacy of the late Grand Chief Sir Michael Somare, whose leadership of the National Alliance Party from 2002-2011 coincided with a period of unprecedented economic growth and political stability.

He attributed this success to the stability brought by OLIPPAC, which helped create a conducive environment for development.

Prime Minister Marape further highlighted his government's plans to introduce a Bill, inspired by recommendations from the Constitutional and Law Reform Commission, to consider the election of the prime minister by the people of Papua New Guinea—an initiative aimed at enhancing the nation's democratic framework.

He urged the Registrar to explore ways in which political parties can contribute to strengthening the political system, supporting effective governance, and fostering a vibrant democracy in Papua New Guinea. ■

Papua New Guinea , Singapore discuss trade and investment opportunities on the margins of CHOGM Leaders' Week in Samoa

Prime Minister Hon. James Marape and his Singapore counterpart, Hon. Lawrence Wong, discussed trade and investment opportunities at their bilateral meeting ahead of the official opening of the 27th Commonwealth Heads of Government Meeting, on Friday 25 October 2024.

He personally congratulated Mr Wong on his ascension to office, in their meeting on the margins of the CHOGM Leaders' week..

The two leaders seized the opportunity to discuss trade and investment opportunities, including new areas of co-operation that will further deepen the ongoing relations.

Prime Minister Marape acknowledged the longstanding

diplomatic relations between Papua New Guinea and Singapore since 1976, affirming that relations between the two countries must continue to new heights.

"PNG knows that Singapore is a hub of transit, operates one of the largest ports in the world, and is a big trading partner with many countries."

Prime Minister Marape emphasised the need to expand relations in the area of trade and investment between Papua New Guinea and Singapore, adding, "We are ready to offer the potential we have for Singapore to tap into PNG's fresh primary agricultural produce to the Singaporean food market."

"This would greatly complement my government's effort to grow the PNG rural economy and improve the

livelihoods of the bulk of our people that are heavily dependent on the agriculture sector," said Prime Minister Marape.

Meanwhile, PNG will be setting up a trade and investment office in Singapore to encourage potential investment in this space and also explore other areas of mutual interest.

Prime Minister Marape also sought support for PNG's full membership to the Association of South East Asian Nations (ASEAN) and informed that PNG would submit its interest through Indonesia by the end of this year.

Prime Minister Wong, in response, expressed appreciation for the warm welcome and thanked Prime Minister Marape for allowing time to meet with him on the margins of his busy

schedule in attending the CHOGM leaders' Week.

He also reiterated that PNG/Singapore bilateral relations are longstanding and that Singapore is an active and constructive partner in the Pacific.

He expressed that their programs in the Pacific aim to be impactful in that they are also an island country and share the same challenges, such as impacts of climate change.

Prime Minister Wong welcomed the proposal for PNG's agricultural produce to be imported into the Singaporean food markets, and added that food diversification and safety standards are an important strategy for adapting to market trends and improving resilience

in a competitive landscape.

Prime Minister Marape in response thanked him for the exchanges and informed that he would be officially conveying a formal letter of invitation to Prime Minister Wong for his attendance at Papua New Guinea's 50th Anniversary in September 2025.

He also expressed his interest for an official visit to Singapore next year to discuss trade and investment opportunities in the area of downstream processing in agriculture, renewable energy resources, fisheries and forestry sectors, in particular, to process and export.

In addition, Prime Minister Marape also welcomed Singaporean investors to Papua New Guinea. ■
